2014 AHDI Integrity Award Winners

LAS VEGAS, NV, July 31, 2014—In support of AHDI's professional programs, standards, and best practices, the Association conducts an annual awards program to acknowledge the significant contributions of its members and other individuals and organizations that have made an impact on the healthcare documentation sector over the previous year. The Association is proud to promote and honor those who have supported the professional practice standards and goals that AHDI has developed for advancing the profession and positioning this sector for continued relevance in the future of healthcare delivery.

Congratulations to all of these dedicated members. Award winners were announced during AHDI's Healthcare Documentation Integrity Conference (HDIC) in Las Vegas, Nevada.

RISING STAR AWARD: Linda Curia

Linda eloquently wrote about the advancements in technology and in health care and stated, "No matter how automated and electronic our industry becomes, there will always be the human factor that we must inject into this industry. As humans, there is always room for error. It is our duty therefore, to always be vigilant in our roles." She closed her essay by saying "If we remain committed to our roles and always strive to do it right the first time, we will achieve our highest level of personal excellence; and in doing so, we will ensure that our healthcare institution achieves its highest level of excellence by providing the best possible care to each and every patient. We all make a difference!"

The Rising Star Award is presented to an outstanding (active) industry student who presented a contemplative and informed response to the Association's annual essay contest. The 2014 essay topic was "How Does Attitude + Commitment = Excellence?"

EDUCATOR OF THE YEAR AWARD: Audrey Kirchner, CHDS

Audrey is a full-time instructor for 360training.com and wrote syllabi and study guides for all courses; developed a mentoring internship for students; uses techniques such as mind mapping strategies to assist students with different learning styles; and also created instructional presentations. Audrey is a volunteer for many AHDI committees and alliances, including being a commissioner on the Credentialing Commission for Healthcare Documentation and with the development of the RHDS Recredentialing Course and the CHDS Bridge Course.

The Educator of the Year Award is presented to an AHDI individual professional member who has demonstrated excellence in the area of education.

EXCELLENCE IN CREDENTIALING AWARD: Audrey Kirchner, CHDS

Audrey has a passion for credentialing. She is currently serving on the Credentialing Commission for Healthcare Documentation and as the leader of R.O.P.E. (Recredentialing Outreach Program and Exchange) for AHDI-West. Audrey helped recruit credit-worthy speakers for the 2014 AHDI conference. Furthermore, Audrey is an advocate for credentialing—she promotes the benefits of credentialing to the industry and she continues to look for ways to help credentialed individuals find quality continuing education opportunities.

The Excellence in Credentialing Award is presented to a credentialed professional who has demonstrated a unique and measurable contribution to the industry during the prior calendar year.

ADVOCATE OF THE YEAR: Linda Allard, CHPS

Linda's passion and goal has always been to help create job opportunities for others and to ensure that those jobs are fair and beneficial to workers. She has contributed to many advocacy-related projects, including lobbying Congress on behalf of the industry, teaching, participating on an Advisory Board, presenting creditworthy continuing education sessions, publishing papers and other works on HIPAA, initiating a voice recognition training program for students, and creating an externship program for clinical documentation students. Linda supports credentialing and provides a reimbursement to all of NEMT personnel for obtaining their CMT/CHDS credential.

This award serves to recognize an individual for outstanding advocacy activities related to advancement of the healthcare documentation profession.

MEMBERSHIP IMPACT AWARD: AHDI-West Regional

AHDI-West participated in conference program planning committees in 2011 and 2012, and hosted the Healthcare Documentation Integrity Conference in 2014, in Las Vegas, NV. AHDI-West initiated ongoing programs such as "Coffee Talk," face-to-face get-togethers with local members to encourage continued membership in AHDI and involvement in AHDI-West; the Corporate Advantage Program (CAP), a year-long webinar series of "mission critical" topics; and R.O.P.E. (Recertification Outreach Program and Exchange), offering assistance to for recredentialing individuals.

The Membership Impact Award is presented to an AHDI component that has engaged in unique initiatives and activities which have measurably impacted component growth, retention, and/or professional development of its members over a two-year period.

EMPLOYER OF THE YEAR AWARD: Amphion Medical Solutions, LLC

Amphion Medical Solutions, LLC, provides their employees a monetary incentive to use toward AHDI membership, continuing education, or recertification fees.
